A letter was read from a man to the prisoner, addressed "Dear Jenny," in which was included "Just a few lines in answer to your kind letter. What a terrible place this is! I could do with your champion here. How I have been longing for you." The letter concluded by a request to allow him, as promised to visit the defendant's rooms when the writer returned, so that they could have a "good time." "Don't we enjoy ourselves," was a phrase also included. The signature of the writer was preceded by "with the best of love," and "six kisses". "This seems to be how they have all been written," remarked the chief constable, Mr Trotter.






